

**ORDINANCE**

**NO. OR04-2009-28**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CLEBURNE, TEXAS AMENDING TITLE IX – GENERAL REGULATIONS, CHAPTER 98 – PARKS AND RECREATION, BY ESTABLISHING SECTION 98.400 – WINSTON PATRICK MCGREGOR PARK: GENERAL RULES; SECTION 98.401 - HOURS OF OPERATION; SECTION 98.402 - FEE SCHEDULE, OF THE CODE OF ORDINANCES; PROVIDING A PENALTY NOT TO EXCEED \$500.00 FOR EACH OFFENSE; PROVIDING FOR PUBLICATION; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Winston Patrick McGregor Park has been constructed for the use of the citizens of Cleburne; and

**WHEREAS**, staff recommends the following fee schedule for use of the facility confident that the proposed fees are competitive within the area market; and

**WHEREAS**, fees should be reviewed annually to determine consistency with Council budget goals;

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CLEBURNE, TEXAS, THAT:**

**SECTION ONE.** Sections 98.400 – Winston Patrick McGregor Park: General Rules, of the Code of Ordinances, City of Cleburne, Texas is hereby established and shall be determined prior to its opening to the public.

**SECTION TWO.** Section 98.401 – Winston Patrick McGregor Park: Hours of Operation shall be 7:00 A.M. – 10:00 P.M. seven days a week.

**SECTION THREE.** Section 98.402 – Winston Patrick McGregor Park, House Rental Fee/Hours of Operation Schedule, of the Code of Ordinances, City of Cleburne, Texas is hereby established as follows:

Section 98.402 (A) - Winston Patrick McGregor Park House hours of operation shall be 8:00 A.M. – 10:00 P.M. seven days a week.

Section 98.402 (B) - Winston Patrick McGregor Park House Fee Schedule

<b><i>Time Session</i></b>	<b><i>Fee Schedule</i></b>
Morning Session 4 Hours (8 am to Noon)	\$50 per 4 hour session
Afternoon Session 4 Hours (1 pm to 5 pm)	\$50 per 4 hour session
Middle Block that spans Morning & Afternoon 4 Hours	\$75 per 4 hour session <i>(Examples: 10 am to 2 pm; 11:00 am to 3:00 pm, luncheon meeting, etc.)</i>
After Hours & Weekends <i>(After 5 pm and Weekends)</i>	\$25 per hour with 2 hour minimum
Botanical or Horticultural Groups <i>(for events that are for public education involving botanical programs/meetings)</i>	No charge <i>(Group must have prior approval as being an approved botanical / horticultural group or organization. Groups are required to set up &amp; take down tables &amp; chairs/clean after use.)</i>

Section 98.404 (C) - Winston Patrick McGregor Park House general rules:

1. There shall be a 10:00 PM curfew.
2. Any event serving alcohol will require off-duty Cleburne Police.
3. There is no allowance or reduction of fees for non-profit organizations.
4. Rental group size is limited to no more than 35 individuals.

**SECTION FOUR.** The City Manager shall be authorized to set or negotiate rates for groups, and special events, and to set other fees that are yet to be determined.

**SECTION FIVE.** Any person, firm, corporation, agent or employee thereof who violates any of the provisions of this Ordinance shall be guilty of a misdemeanor and upon conviction thereof shall be fined not to exceed Five Hundred and No/100 dollars (\$500.00) for each offense. Each day that a violation is permitted to exist shall constitute a separate offense.

**SECTION SIX.** The caption of this Ordinance shall be published twice within ten (10) days of its passage in a newspaper of general circulation in the City of Cleburne, in compliance with the provisions of Article III, Section 51, of the City Charter.

**SECTION SEVEN.** This Ordinance shall become effective ten (10) days after the date of its passage and upon its publication as required by law.
